
Supporting Communities Hit Hardest By the COVID-19 Pandemic

Millions of pregnant women, infants, toddlers, and families—disproportionately in communities of color—have experienced devastating economic and health impacts from this unprecedented pandemic. Early Head Start can support them. We know that child poverty and hunger have risen during this pandemic, while child well-being has declined. The social isolation caused by COVID-19 has impacted brain development and left young children more vulnerable to trauma, abuse, and neglect. This crisis has also highlighted alarming disparities in health outcomes for young children.

Now is the time to expand Early Head Start, especially to support the low-income communities and communities of color hit hardest by this pandemic. Early Head Start is designed to serve these families specifically, with its **comprehensive multigenerational approach**, proven to support healthy development of the whole child by connecting families to medical homes, providing developmental screenings, and nurturing positive adult-child relationships through culturally and linguistically appropriate approaches.

Early Head Start's flexible model, which includes year-round support, home-based options and robust partnership opportunities with child care partners, is built for this moment. No other early childhood program attends to the cultural and linguistic diversity of U.S. families or is as skilled at addressing childhood trauma. The connection to Head Start supports continued development of children and families as they get ready for Kindergarten.





Decision Makers have the power to expand Early Head Start.

1. Congress

Congress knows how to expand Early Head Start. Responding to the Great Recession in 2009, Congress grew Early Head Start slots by nearly 75% (see chart above). Since, they have invested in additional slots and expanded the program through <u>Early Head Start-Child Care Partnerships</u>. They can do it again.

2. The Office of Head Start

The Office of Head Start and the Administration for Children in Families have many pathways to Early Head Start expansion, including better aligning child care and Early Head Start systems, expanding Regional Office support for grantees, and developing a pipeline of new sites and programs.


3. State Governments

States are making unprecedented investments in early childhood, and <u>a number of states either invest</u> <u>directly in Early Head Start</u> or programs modeled on it. They have the power to address systemic issues to expansion, such as low compensation for early educators and facility improvements.

4. Programs

Finally, Early Head Start and Head Start programs are ready to grow, recognizing the huge demand for prenatal care and high-quality infant and toddler care and support in their communities.

10 Effective Strategies

Among the four key decision makers, there are at least 10 effective levers to pull to expand Early Head Start.

	Levers to Pull	Description
Congress	Federal base funding	Permanently expanding the number of EHS slots funded on an annual basis
	COVID-19 funding	Providing COVID-19 recovery funding to expand EHS and create or improve facilities
	Head Start Act Reauthorization	Strengthening the prenatal-to-age-five continuum in the next reauthorization of the Head Start Act and addressing eligibility
Office of Head Start / Administration for Children and Families	Systems Alignment	Promoting systems-level partnerships with child care, in particular, and around issues of equity
	Regional Office Support	Ensuring consistent support for EHS across regions
	Pipeline Development	Identifying and engaging a pool of providers interested in providing or expanding EHS services
States	State Support	Providing state funding, workforce supports, and investments in facilities
	Child Care Partnerships	An expanded commitment to Early Head Start-Child Care Partnerships and layered funding
Programs	Effective Practice Supports	Expanding effective practice supports to help programs deliver high-quality services
	Conversion	Supporting the conversion of HS slots to EHS slots


