### Strengthening Outcomes for Expectant Families

The [Documenting and Providing Services to Expectant Families](#) webinar featured an overview of [ACF-IM-HS-22-02 Documenting Services to Enrolled Pregnant Women](#) and showcased Early Head Start grant recipients from across the country. As I listened to program representatives reflect on their services, a few points struck me:

- Programs prioritize and intentionally provide services to expectant families. One program discussed looking at their community data and realizing that a full-time prenatal coordinator was necessary to support birthing parents.
- Head Start programs are well-positioned to influence maternal health disparities through the provision of comprehensive services and community partnerships.
- Programs can help create and strengthen networks of support for families.
- Representatives on the Health Services Advisory Committee (HSAC) can help inform services to birthing persons. They can also become better informed about the needs of expectant families through their participation in the HSAC.

## More care options for traveling employees



As your employees are getting back to business trips and family vacations, the last thing they want to worry about on the journey is their health coverage. Now, it's easier than ever to get care if something unexpected happens while they're traveling.

### Routine care

Members can always schedule in-person, phone, or video visits in states with Kaiser Permanente facilities.

### Urgent care

Members can get urgent care anywhere in the world. And at many locations outside Kaiser Permanente states, they'll only pay their copay or coinsurance – no need to file a claim:

- Cigna PPO Network\*
- MinuteClinic®, including pharmacies
- Concentra

In some places, members can also get 24/7 medical advice by phone or video from a Kaiser Permanente clinician. At all other locations, members can pay the full cost of care upfront and file a claim for reimbursement later.

### Emergency care

## IMPORTANT REMINDER

Just another reminder to please be very careful with your email correspondence and always be on the lookout for *phishing emails* that may happen to land in your Inbox. I appreciate the Child Start staff member who submitted this to IT and for being vigilant and immediately suspecting that the email message to *not* be legitimate.

Here is a screenshot of the email message “supposedly” sent by a *Child Start employee*:

Some questions to ask yourself:

The sender's email address, ***rightbox@mail.com*** should immediately raise a flag that this is a suspicious email.

- Why didn't this Child Start employee use their Child Start email address (account) OR why did they use an email address that doesn't readily identify her or him?
- Does the email require action on my part?
  - especially if the action involves sending and providing sensitive information to the sender (i.e., Social Security numbers, Employee and/or Payroll IDs, etc.,
  - a request to change personnel information on file

Now if the email address showed an email address that followed Child Start's naming convention (first name initial, last name) but ***had a domain name other than @childstartinc.org*** (e.g., if the employee's name is John Doe, the email address would be [jdoe@childstartinc.org](mailto:jdoe@childstartinc.org) but the email you received had [jdoe@gmail.com](mailto:jdoe@gmail.com) as the email address), you should ***send a NEW email message*** to the sender *with their Child Start email address* to verify the validity of the email you had received – **DO NOT REPLY BACK TO THE SUSPICIOUS EMAIL.**

***Please refrain from “Replying-to-All” and direct any questions/concerns to myself or the IT Helpdesk.***
